**SUPPLY, INSTALLATION, TESTING , OPERATIONALIZING AND

I. GENERAL TERMS AND CONDITIONS

- a) This Tender is invited for the **Supply, Installation, Testing, Operationalizing and Maintenance of IP based CCTV Surveillance Security cameras at Various Locations along with Integration of Existing CCTV Surveillance System Installed at Kunnamkulam Taluk Hospital, Thrissur**, one of the projects undertaken by C-DIT.
- b) C-DIT reserves the right to cancel any or all tenders without assigning any reason whatsoever

II. ELIGIBILITY CRITERIA OF BIDDER

- a) Bidder should be a registered company or registered business firm as per Indian Law, doing similar business.
- b) The bidder should have a registered office in Kerala (**Documentary Evidence should be attached**) and a well-equipped authorised service centre (Preferably at Thrissur or Palakkad).
- c) Bidders should have valid GST registration.
- d) Bidders should have PAN allotted to him by IT Department.
- e) Bidder shall not be blacklisted by any of the department/organizations of the Govt. of India/State Govt/PSUs.

- f) To qualify for award of the work, the intending tenderer must have an experience in successfully completed at least three orders of similar nature having contract value not less than 1.5 lakh each during last 2 years. **(Documents should be attached)**

III. SCOPE OF WORK

To identify integrators/ contractors for undertaking the work for the Supply, Installation, Testing, Operationalizing and Maintenance of IP based CCTV Surveillance Security cameras at Various Locations along with Integration of Existing CCTV Surveillance System Installed at **Kunnamkulam Taluk Hospital, Thrissur.**

IV. SPECIAL CONDITIONS FOR THIS WORK

1. It is mandatory for the bidder to deploy qualified professionals to install, commission & maintain the equipment, as defined under scope of work.
2. The successful bidder should supply all equipment/ materials required to execute the work in the respective sites as per the Bill of Material quoted.
3. The successful bidder should install CCTV surveillance system components as per the specifications prescribed in the tender document and should install the cameras in the **Proposed Locations detailed in this document.**
4. The successful bidder should integrate the newly installed CCTV components with

the existing surveillance system installed there.

5. All the Cameras have to be cabled by UTP CAT-6 Cable inside the Buildings and STP CAT6 cable for outside cabling and connected to PoE Switch using structured cabling for the LAN. Proper conduit as per the specification should be provided.
6. The successful bidder shall carry out the necessary civil and electrical works to install the entire solution.
7. The bidder is responsible to perform the highest quality of workmanship, including ensuring aesthetics while executing this project. The bidder should ensure that the cables and equipment are placed with proper routing of cables keeping the aesthetics of the site environment intact.
8. The Camera Video feeds have to be transmitted 24X7 and should be able to view in the Monitor already installed there. (Through Mobile/ Tab if required).
9. The work includes the installation of cameras for proper surveillance coverage at each location. The camera locations are mentioned in this document, however, the locations at the time of installation may change based on the site requirement.
10. The technical specifications mentioned in this document are the minimum suggestive specifications. The vendor not meeting these minimum suggestive technical specifications are liable to be rejected.
- 11. Bidder should survey and evaluate the site conditions, if necessary, before submitting offers and are responsible to supply and install the surveillance system including all necessary cabling, conduits, wiring and other related accessories.**
- 12. The bidder shall ensure three years comprehensive warranty as per this document to all equipment, parts supplied including all works associated with the project from the date of successful User Acceptance Test.**
- 13. The bidder should submit MAF - Manufacturer's Authorization Form for the Cameras, NVR, Switches.**
14. Successful bidder should provide training to the team identified by the user for

operation of the CCTV System and handhold on job.

15. The bidder shall handover all software products license keys/ passwords/ softwares/ installation files including user manual and all necessary documentation to C-DIT.
