TENDER FOR THE SUPPLY OF 2MP IP BULLET CAMERA

A) GENERAL TERMS AND CONDITIONS

- a) This Tender is invited for the" **Supply of 2MP IP Bullet camera at C-DIT Office, Thiruvallam, Thiruvananthapuram**" as per the tender specification.
- b) C-DIT reserves the right to cancel any or all tenders without assigning any reason whatsoever.

B) SCOPE OF WORK

Scope of work primarily includes Supply of **2MP IP Bullet camera** at CDIT, Thiruvallam, Thiruvananthapuram for the projects undertaken by C-DIT as per the tender specification.

C) ELIGIBILITY CRITERIA OF TENDERER

Only those firms which in their individual capacity, satisfy the following criteria, need to quote for this tender.

1. The bidder must be an OEM or an OEM authorized distributor/ supplier of the quoted items with prior experience in supply of the same or similar equipment in the last two years with total executed order quantity worth ₹ 25 lakh or above. The bidder should submit the documents showing the experience and MAF - Manufacturer's Authorization Form for the required items.
2. Bidder should be a registered company or registered business firm as per Indian Law, doing similar business.
3. The bidder should have a registered office and authorised service centres in Kerala.
4. The bidder must have a currently valid GST registration certificate and PAN number.
5. Bidder should have a minimum annual turnover of 25 lakhs (Twenty-Five Lakhs) for the last 3 years. **Proof should be attached.**
6. An undertaking to the effect that the bidder has not been blacklisted by any of the department/organizations of the Govt. of India/State Govt /PSUs

D) OTHER TERMS AND CONDITIONS

7. **The approximate quantity of camera required will be 200 Nos each. The quantity indicated in the tender are indicative and purchase orders may be placed for lesser or more quantity.**
8. There is a separate price bid form attached along with this tender. The supplier shall submit the price offers in their own paper.
9. The Bidders are responsible for effecting supply to the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the item supplied is noticed, such item will be rejected at the risk and cost of the Supplier.
10. The bidder shall supply the cameras at C-DIT Office or any other offices in Kerala as specified in the Purchase order.
11. **The successful bidder shall be responsible to supply the Camera within 5 days from the date of issuance of Purchase order.**
12. Technical and other details of the items offered 'brand make' and complete specification should be mentioned in the tender. In the absence of full details and specification, the tenders for the items will be rejected.

13. CDIT reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the ground of purchaser action.
14. CDIT is not bound to assign any reason for rejecting any or all the tenders. It also reserves the right to accept/reject (part/whole) or any other tender(s) at their sole discretion without assigning any reason thereof. Its decision in the matter shall be final and binding.
15. The rate quoted by the Tenderer shall be inclusive of transportation charges and unloading charges. Rates quoted by the tenderer shall be valid for a period of six months from the date of opening of the tender.
16. Bidder should not quote discontinued Brands or Models.
17. No advance payment will be made against supplies.
18. **During the technical evaluation, the bidders shall demonstrate the proposed camera units integrated with VMS Software and Mobile App. The shortlisted bidders shall arrange a demonstration of items on 25.05.2024 Saturday at 10.00AM at Thiruvananthapuram. The exact venue will be informed to the shortlisted bidders.**
19. The components/parts of the machine specified should be of the same OEM or the one that is authorized by the manufacturer. The supplier should verify that all parts adhere to the conditions mentioned above.
20. The undersigned does not bind himself to accept the lowest tender and reserve himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to supply the accepted item at the rates quoted.
21. The rate should be quoted for the unit shown in the list and tenders which do not indicate this essential information will not be considered.
22. The rate quoted for item/ material is final and no enhancement will be allowed under any circumstances. The enhancement of rate will cause the cancellation of the supply order and the security deposit will be forfeited.
23. If the tenderer furnishes wrong and/or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender will be liable to be ignored and rejected in addition to other remedies available to the purchaser in this regard.
24. All items offered shall conform in all respects to the relevant Indian standard Specification with up-to-date amendments wherever applicable.

- 25. EMD: The bidder shall submit EMD of Rs. 10,000/- (Rupees Ten Thousand only) along with the tender in the form of Demand draft drawn in favour of The Registrar, C-DIT, payable at Thiruvananthapuram**
- 26.** Delivery period shall be specifically indicated in the tender and strictly adhered to. If no delivery period is stated in the tender it will be taken for granted that the supply will be arranged within Five days (5) days on receipt of the firm order. Any extension in the delivery period after the supply order is placed may result in cancellation of the supply order. In case the Bidder became unable to supply within the time limit prescribed by C-DIT, the supply order is likely to be cancelled and items will be arranged by C-DIT from elsewhere and the earnest money deposited along with security deposit collected from the bidder will be forfeited.
- 27.** Any dispute / differences between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations. Unresolved disputes/ differences, if any, shall be settled by Arbitration and the arbitration proceedings shall be conducted at Thiruvananthapuram (India) in English language, under the Indian Arbitration and Conciliation (Amendment) Act, 2015. Unsettled disputes will be referred to courts and courts in Thiruvananthapuram/ Kerala will have exclusive jurisdiction over the same.
- 28.** Tender Submission: The tender shall be submitted as e tenders through- web portal: www.etenders.kerala.gov.in. Since this is an e-tender, only those bidders who have the enrolment in the above portal with their own digital signature certificate (DSC) can participate in the tender. Tender documents and other details can be obtained from the portal.
- 29.** Performance Bank Guarantee (PBG)/Security Deposit: The Bidder, in the event of an order, should furnish a bank Guarantee from an Indian Schedule/Nationalized Bank at no extra cost in a Performa prescribed by C-DIT for an amount equivalent to 5% (Five percent) of the value of the contract. The PBG shall be valid for period of 12 months from the date of commissioning of the work at C-DIT.
- 30.** The successful bidder who claims Bid Security/EMD Exemptions should furnish the Bid Security Declaration form on a stamp paper worth ₹ 200/-, in the format attached as 'Annexure I', and should submit in C-DIT after getting the Purchase order. The original/hard copy shall be sent by registered post addressed to The Registrar, C-DIT, Chithranjali Hills, Thiruvallam, Thiruvananthapuram- 695027.
- 31. PAYMENT TERMS** - 80% payment would be released on successful delivery & POST operation (Power-On Self-Test) of the supplied machine as per the Purchase Order (PO). Remaining 20% of payment shall be released after completing implementation and test period of three month from the date of installation.

32. WARRANTY

- The bidder shall provide onsite comprehensive OEM warranty for the Items supplied from the date of supply.
- The OEM should provide onsite support, spares and other consumables throughout the warranty period, irrespective of product change or depreciation of the product.

33. AFTER SALES SERVICE

- Service support personnel should be available at any time on demand.
- The Telephone Number and address of the designated persons should be submitted for reporting faults during the warranty period.

34. **Agreement:** The Successful bidder within 7 days of getting confirmed work order has to enter an agreement with C-DIT in Rs.200 worth non judicial stamp paper, to ensure warranty and after sales support during the warranty period.

35. Authority: The authority for the acceptance of the tender's rests exclusively with the C-DIT.

36. At any time prior to the deadline for submission of tenders, the C-DIT may, for any reason deemed fit by it, modify/amend the tender documents by issuing suitable amendment(s)/ corrigendum's to it.
